# EXCERPT FROM DECISIONS OF THE ACADEMIC COUNCIL ACCORDING TO PROTOCOL № 25 FROM 30.06.2025

regarding the increase of

Basic Salary for the position of "Assistant."

The Academic Council decided:

- **I.** To update the basic salaries of employees holding the academic position of "Assistant" to 2780 BGN, effective from January 1, 2025.
- II. Pursuant to §4 of the Final Provisions of the Internal Regulations for Remuneration (IRR) and in accordance with Art. 16, para. 6 of the IRR, the Academic Council decided to update Appendix 1 to the Internal Regulations for Remuneration at MU-Varna, "Minimum Basic Salaries for Positions and Staff Categories," according to Appendix № 2 hereto. In the Final Provisions of the IRR, a new § 32 shall be created with the following text: "The Internal Regulations for Remuneration have been amended and supplemented by a decision of the Academic Council according to Protocol № 25/30.06.2025 and enter into force from the date of the Rector's order for their approval, unless another date is specified in the order."

regarding the amendment of the Internal Regulations for Remuneration at MU-Varna.

The Academic Council decided:

- 1. Amends the Internal Regulations for Remuneration of MU-Varna, as follows:
- Para. 5 of Art. 27 is repealed.
- Para. 4 of Art. 31 is repealed.
- Para. 5 of Art. 31a is repealed.
- Para. 4 of Art. 32b is repealed.

A new § 32 is created with the following text: "The Internal Regulations for Remuneration have been amended and supplemented by a decision of the Academic Council according to Protocol  $N \ge 25/30.06.2025$  and enter into force as of the date of the Rector's order for their approval, unless another date is specified in the order."

**regarding** an Amendment to the "Regulations for Publishing Activities of Medical University 'Prof. Dr. Paraskev Stoyanov' – Varna"

The Academic Council adopts the following amendments to the Regulations for Publishing Activities of Medical University "Prof. Dr. Paraskev Stoyanov" – Varna, adopted on 12.08.2020, last amended on 03.09.2021:

## §1. A new Article 6a is created:

- "Art. 6a. (1) Upon a proposal from the Vice-Rector for Research, the Rector may approve document templates for specific publishing activities, including, but not limited to, contracts, agreements, declarations, forms, etc.
- (2) If a document template has been approved by the Rector but is not applicable to a specific case, the document shall be coordinated with a lawyer."

## §2. In Art. 7, Para. 4, Item 5 is amended as follows:

"5. additional editions of publications included in the approved publishing plans of previous years, in the event of exhaustion of the printed editions."

#### §3. Art. 8, Para. 3 is amended as follows:

"(3) Additional print runs of textbooks, teaching aids, and collections for prospective students shall be printed with priority."

# §4. Art. 9, Para. 2 is amended as follows:

"(2) Proposals shall be made in accordance with the needs for academic literature, submitted through the Automated Information System 'Document Management' of MU-Varna, accompanied by the final manuscript of the publication, and shall comply with:"

# §5. Art. 11 is amended as follows:

"The print runs of published literature are determined by the Publishing Council based on the projected number of enrolled students and expected prospective students, in compliance with the active Copyright Law and Personal Data Protection Law, the Internal Procedure for Awarding Contracts for Publishing and Distribution of Publishing Products, and the concluded distribution agreements."

## § 6. The following amendments and additions are made to Art. 12:

# 1. In paragraph 1:

"(1) The author concludes a publishing contract with MU-Varna, granting the exclusive right to publish, republish and distribute to the publisher for a period of five years."

# 2. In paragraph 3:

"(3) In cases where the author is in an employment relationship with MU-Varna, an additional agreement to the employment contract is concluded for a period of five years. The author receives remuneration in accordance with the current Internal Regulations for Remuneration and these regulations."

# 3. New paragraph 4:

" (4) When the author is assoc. professor or professor person who has reached the age under Art. 328, para. 1, item 10 of the Labor Code, a publishing contract shall be concluded."

#### 4. Paragraph 5 is created:

"(5) When submitting articles for publication in the periodicals of MU-Varna, the author signs a Declaration of Authorship under Art. 18 of the Law on the Protection of Scientific and Technical Resources. The declaration can be submitted in person or electronically through the MU-Varna platform "Scientific Online Resource System".

# §7. Article 15a is repealed.

- §8. Article 20, Paragraphs 5 and 6 are repealed.
- §9. In the Transitional and Final Provisions, §6 is added with the following text:"
- §6. For authors in an employment relationship with MU-Varna who, as of now, have not received author's remuneration or the value of in-kind publications, as per issued orders, due to not having worked days in the month of payment because of legally established leave (for temporary incapacity, pregnancy and childbirth, adoption, childcare, and unpaid leave) and continue to be absent, the amounts shall be calculated and paid in the recapitulation for July 2025."

**Appendix:** Draft of the Regulations for Publishing Activities of Medical University "Prof. Dr. Paraskev Stoyanov" – Varna.

**regarding** the Updating of Training Programs for Highly Specialized Activities (HSA) "Arthroscopy" and HSA "Joint Endoprosthetics" and Amendment and Supplementation of the Rules for the Organization and Procedure for Conducting Training for Highly Specialized Activities (HSA) at MU-Varna.

The Academic Council decided:

- 1. To amend and supplement the Rules for the Organization and Procedure for Conducting Training for Highly Specialized Activities (HSA) at MU-Varna, as follows:
- §1 In Section "Va. Termination of HSA Training":
  - 1. A new sub-point 19a.3. is created with the following content: "19a.3. Two unsuccessful attempts on the entrance test at the start of training, when such a test is required according to the respective curriculum."
  - 2. Point 19b. takes on the following form: "19b. Within seven days of the occurrence of the circumstance under points 19a.1 and 19a.2, the trainee is obliged to provide the training

supervisor with relevant evidence of the circumstance under Art. 157, para. 1, points 1-4 and Art. 162, para. 1 of the Labor Code."

# 3. Point 19c. shall take the following form:

" 19c. In the event that the student fails to fulfill their obligation under item 19b within the required period, as well as in cases under point 19a.3, the training supervisor shall notify the Vice-Rector "Postgraduate Education" of the occurrence of the circumstance under point 19a, via a report signed by the chairperson of the HSA examination committee."

## §2 Sub-point 23.3. now reads as follows:

- "23.3. The Examination Committee reviews the documents and makes one of the following decisions, recorded in a protocol:
  - Does not recognize the conducted training and requires training for the full duration;
  - Recognizes the conducted training and sets a period for additional study;
  - Recognizes the conducted training as compliant with the program requirements for completed full training and duration, and schedules an exam date."
- §3 Everywhere the word "legal capacity" is replaced by the words "professional qualification".
- §4 In point 21, the word "receive" is replaced by "acquires".
- 2 The updated training program for HSA "Arthroscopy" is adopted.
- 3 The updated training program for HSA "Joint Endoprosthetics" is adopted.
- 4 The nomenclature of HSA at MU-Varna is supplemented, with row 12 and row 13 now appearing as follows:

Health and Sports, professional field 7.2 Dentistry, for the Department of "Dental Materials Science and Prosthetic Dentistry", Faculty of Dentistry.

The Academic Council decided to open the position of "lecturer in the specialty "Clinical Pharmacy", **0.5 full-time position** for the Department of Pharmacology, Toxicology and Pharmacotherapy at the Faculty of Pharmacy.

**regarding** the announcement of competitions for the positions of "Assistant and Chief Assistant".

The Academic Council decided to announce a competition for the academic position of "Assistant" in the specialty "Inorganic Chemistry", in the field of higher education 4.Natural Sciences, Mathematics and Informatics, professional field 4.2. Chemical Sciences, Department of "Chemistry" at the Faculty of Pharmacy, (1.0 full-time position).

The Academic Council decided to extend, after reaching the age of majority under Art. 328, para. 1, item 10 of the Labor Code, the employment contract of: **Assoc. Prof. Dr. Evgeniya Dencheva Kalevska, MD** - Department of Nervous Diseases and Neurosciences, for a period of one year starting from 28.07.2025 /first extension/.

**regarding** the organization of the Ninth Varna Summer School "Introduction to Emergency Medicine"

The Academic Council decided that the Medical University of Varna will organize the **Ninth Varna Summer School "Introduction to Emergency Medicine"** for fifth and sixth-year medical students. The school will take place from July 18, 2025, to July 29, 2025, during a period free from semester and state examinations. It will include a two-day theoretical module at the Second Auditorium of MU-Varna and a ten-day practical module at the Emergency Medical Center -Varna and the emergency department of "St. Marina" University Hospital, Varna.

**Regarding** the approval of the curriculum for admission 2025/2026, specialty "Medicine" and updating of existing curricula.

The Academic Council approves the new curriculum of the specialty "Medicine" for admission 2025/2026 and the updated curricula of the current classes in accordance with the newly adopted curriculum for the academic year 2025/2026.

The Academic Council approves the following prices for participation in the XIX International Congress on Colorectal Surgery, which will be held from October 9-11, 2025, in "St. Konstantin and Elena," Varna:

- **10,000 BGN** (excluding VAT) Gold Sponsor with the right to present products at one small virtual stand + a small physical stand in the hotel lobby;

Requirements for candidates: higher education, Master's degree in "English Philology," with 2 (two) years of teaching experience and excellent skills in working with information and communication technologies.
