After graduating from the Faculty of Medicine, during the period from 2010 to 2011, Dr. Antoineta Georgieva worked in a pharmacy. Since 2012, Dr. Georgieva has been an assistant at the Department of Pharmacology and Clinical Pharmacology and Therapy at the Faculty of Medicine at the Medical University - Varna. In 2016, she successfully defended his doctorate in the specialty "Pharmacology (incl. pharmacokinetics and chemotherapy)" at the Faculty of Medicine at the Medical University "Prof. Dr. Paraskev Stoyanov"-Varna. She has an acquired specialty in "Pharmacology" (2021). In 2017, the candidate acquired the academic position of "Chief Assistant Professor".

Ch. Assistant professor Dr. Antoineta Georgieva has 12 years of teaching experience in teaching at the Medical University - Varna in the discipline "Pharmacology" to students from the specialties of medicine and dentistry and in the discipline "Clinical pharmacology" to students from the specialties of medicine and dentistry.

Potential health benefits based on polyphenol content", list of participations in national and international scientific forums, list of participations in scientific projects and reference for scientific contributions. The documents are submitted on an electronic medium.

III. Evaluation of the scientific works of the candidate for the overall academic development

Ch. Assistant Professor Dr. Antoaneta Georgieva presented an academic reference for a total of 24 scientific articles related to the competition for the academic position "Associate Professor" and 18 scientific works outside of it.

The candidate participates in the competition with a monograph and 24 scientific articles, as follows:

- In 7 of the presented articles related to the competition for the academic position "Associate Professor" Dr. Antoaneta Georgieva, is the first author.

In his self-evaluation, the candidate divided the points to be awarded for each presented scientific work, in proportion to the number of co-authors, and the candidate's points by groups of indicators, which I recognize, are as follows: indicator A - 50 points, indicator B - 100 points and indicator D - 202.1 points.

The candidate meets the normative requirements for publication activity (indicator B-100 points with a requirement of 100 points and indicator D-202.1 points with a requirement of 200 points).

IV. Evaluation of the monographic work submitted for participation in the competition

Candidate Dr. Antoineta Georgieva presented a monograph named "Traditional Bulgarian spices devesil, savory, fenugreek/chime. Potential health benefits based on polyphenol content". The potential health benefits of the extracts isolated from these plants are based on the content of flavonoids (quercetin, kaempferol, rutin, apigenin, luteolin) and phenolic acids (chlorogenic, ferulic, gallic, caffeic, vanillic).

The scientific contributions related to the presented monograph of the candidate have important scientific and applied importance. The potential multiple health benefits of the traditional Bulgarian spices devesil (Levisticum officinale), savory (plants of the genus Satureja), and fenugreek/chime (Trigonella foenum-graecum) due to their high content of polyphenolic compounds have been elucidated. Data are presented on the pharmacological effects of various plants and of isolated polyphenols (flavonoids and phenolic acids) in experimental models of diseases and conditions. The presented antioxidant, anti-inflammatory, antitumor, neuroprotective, organoprotective, metabolic, antibacterial, antiviral and antiparasitic properties are based on both literature sources and own experimental data.

V. Citation of the candidate's publications in the national and foreign literature

According to the Academic Reference of the candidate from the Library of the Medical University - Varna, 7 citations (105 points) are presented against the requirement of 50 points.

VI. Assessment of teaching activities

From 2012 until now, the candidate has been conducting practical classes for students in the disciplines of pharmacology and clinical pharmacology at the Medical faculty of the Medical University "Prof. Dr. Paraskev Stovanov"-Varna.

According to the academic report for the last 4 academic years, Dr. Antoineta Georgieva has an average of 619 hours/academic year in practical seminars, which many times exceeds the norm for classroom employment for one academic year (360 hours).
