In 2006, he started working as a resident in the Department of Vascular Surgery, which was later transformed into the Clinic of Vascular Surgery at the University Hospital "St. Marina" - Varna, and in 2022. defended a dissertation on the topic

For his participation in this competition, Dr. Jordanov presents:

- 6 publications in scientific publications, indexed in world-renowned databases of scientific information (Web of Science and Scopus)

- 19 publications in non-refereed scientific publications - 17 in Bulgarian and 2 in foreign publications.

His positioning as an author is distributed as follows:

second author in 7 publications

During the years of his scientific activity, Dr. Emil Jordanov has participated in a number of national and international scientific forums with reports in which he was an author and co-author.

Teaching and teaching activities

Dr. Emil Jordanov is a chief assistant professor in the Department of Cardiovascular Surgery and Angiology and leads exercises and lectures to students studying in English and Bulgarian at the Faculty of Medicine and to students of general surgery at the Faculty of Dental Medicine. The candidate also conducts training in surgery and to intern doctors. The submitted certificate shows that the candidate also has the necessary academic workload, according to the requirements of the regulatory framework.

Contributions

The presented publications and dissertation work form show different fields of interest in the clinical and scientific development of problems related to the diagnosis and treatment of vascular diseases. In his dissertation work, Dr. Jordanov presents significant contributions in the field of diagnosis and treatment of carotid pathology, as well as in the features of the diagnosis and treatment of its accompanying comorbidity, especially multifocal atherosclerosis. The candidate has worked actively in the field of diseases of the abdominal aorta and its main branches, as well as in the field of emergency vascular surgery. Dr. Jordanov has registered certain interests in the treatment and follow-up of patients with other major diseases occurring in combination with vascular pathology. In some of his scientific publications, the candidate also considers new innovative methods for the diagnosis of reconstructions of arterial vessels in the extremities. The casuistic cases presented by the candidate are definitely of practical and scientific value and are useful for both students and established specialists dealing with vascular pathology. Dr. Jordanov also presents developments in the field of abdominal surgery, which also confirm his broad interests in the diagnosis and treatment of medical pathology. His publications related to the history of medicine are also of categorical interest and value.
