Professional biography data:

Dr. Maria Dimova graduated in medicine in 2001. in MU-Varna with excellent success. She began her professional development as a resident doctor in Internal Medicine Ward – Silistra. Since 2004 she is a physician at the Department of Propaedeutics of Internal Medicine and subsequently with acquisition of specialty in Internal Medicine and Cardiology she occupied the position of Assistant and Chief Assistant subsequently. Since 2015 she is a full-time PhD candidate in Cardiology and successfully defended her dissertation on the topic "Prospective Follow-up Of Patients With Beta-Thalassemia Major For Cardio-vascular Status And Cardio-vascular Pathology""- 2017

Scientific contributions:

Dr. Maria Dimova's scientific work characterizes her as a focused clinician on specific cardiac pathology in other internal diseases, such as anemia, thyroid pathology, etc. Imaging diagnostics is also in the focus of her clinical and scientific attention. HER research addresses a number of problems of cardiovascular disease, which I would summarize in several directions:

According to the citation provided by the Library of Varna Medical University, there are 10 citations in Bulgarian articles, published in Bulgarian journals.

Dr. Mileva's teaching activities include working with students in Medicine at the Department of "Propedeutics of Internal Medicine Medicine". Dr. Maria Dimova

gained experience and went through all the development from assistant to chief assistant. The academic workload in 2014/2019 accounts for 164-180 academic hour per year. The light deficit in academic workload I explain with the focus on doctoral studies she had in these years.

Dr. Dimova's teaching load is her teaching experience it is satisfactory and it is important for her development as an academic assistant profesor.

Expert and medical-diagnostic activity:

Dr. Maria Dimova has worked and conducted her training in a leading University Hospital in Bulgaria. She is certified cardiologist and specialist in internal medicine, certified specialist in the field of ultrasound diagnostic internal medicine. *The above data are evidence of a good level of professional competence that Dr. Dimova has.*

In Conclusion:

Dr. Maria Stoyanova Dimova - Mileva is a university lecturer, a researcher who has experience in several aspects of cardiology, as in other areas of internal medicine, which is inherent in academic educators in the Department of Propedeutics of internal medicine. Scientific activity and systematicity of publications characterize her as a deep and serious researcher in the field of narrow spectrum in the many field of cardiology. I think that she should put some more effort in her further developmet a teacher in the field of cardiology following the tradition of thedepartment.
