2016 to present - Associate Professor in the Department of Pediatric Dentistry at SPF-Varna

2018 acquires the Doctor of Science in the specialty "Pediatric Dentistry"

2018 - 2020 - Deputy Dean of the Faculty of Dental Medicine at MU-Varna

III. Evaluation of scientific production

In the academic report on the publications, citations and scientific profiles of Assoc. Prof. Dr. Radosveta Stoyanova Andreeva - Borisova, MD, the scientometric indicators for holding the academic position of "professor" include:

- · Dissertation for the acquisition of ONS "Doctor" on "Premature loss of temporary teeth in children with mixed dentition. Need for guardians';
- · Dissertation for the acquisition of NS "Doctor of Science" on "Complex dental treatment in children under general anesthesia";
- · Monographic work on "Pharmacological influence of the behavior of children with special health needs in need of dental treatment", 2020, ISBN 978-619-7486-05-6;
- · 17 articles, 2 of which are in referenced and indexed editions in Scopus and Web of Science.

The total number of points from the actual published articles is 336.5.

In 6 publications Assoc. Prof. Andreeva is a sole author, in 2 she is the first author, in 2 she is a second author and in the other 9 she is another author.

The monographic work has been developed in this thematic area, as 5 additional publications on the topic have been made (2, 8, 11, 12 and 13).

Two publications are included in this field (1, 10).

A total of 10 publications are included in this area, which are made on various topics (3, 4, 5, 6, 7, 9, 14, 15, 16, 17).

V. Assessment of learning activities

Assoc. Prof. Dr. Radosveta Andreeva is an experienced university lecturer. During her professional career as such, she participated in the training of students, postgraduates and doctoral students. Assoc. Prof. Andreeva leads a lecture course in pediatric dentistry for dental students in Bulgarian and English. Participates in: semester and state exams for students; colloquia, practical and theoretical exams for graduates; examination commissions for conducting competitions for assistants, doctoral students and postgraduates. The report on the workload shows between 359 and 462 hours of annual classroom employment in the last four years at a norm of 90 hours. The presented data for the teaching activity prove that Assoc. Prof. Dr. Radosveta Andreeva is a lecturer with the necessary experience and knowledge to hold the academic position of "professor".

VI. Medical-diagnostic activity

Assoc. Prof. Andreeva has 23 years of experience as a dentist.
