EXCERPT FROM THE DECISIONS OF THE ACADEMIC COUNCIL Protocol No. 30 of 29 October 2025

Regarding the approval of amendments to the "Rules and Regulations for the Awarding Scholarships at the Medical University 'Prof. Dr. Paraskev Stoyanov' – Varna"

The Academic Council adopts the following amendments to the Rules and Regulations for the Awarding Scholarships at the Medical University – Varna:

- **§1.** In Section I "Scholarships for Bulgarian PhD Students," in Item 2 of Subsection I "Scholarships Paid from the State Subsidy," the number "1227" shall be replaced with "1562."
- **§2.** In Section I "Scholarships for Bulgarian PhD Students," in Subitem 4.1 of Item 4 of Subsection I "Scholarships Paid from the State Subsidy," the number "1227" shall be replaced with "1562."
- **§3.** In Section I "Scholarships for Bulgarian PhD Students," in Subitem 4.2 of Item 4 of Subsection I "Scholarships Paid from the State Subsidy," the number "1227" shall be replaced with "1562."
- **§4.** In Section II "Scholarships for Foreign PhD Students and Postgraduate Trainees," in Item 2, the number "1227" shall be replaced with "1562."
- §5. A new §5 shall be added to the "Transitional and Final Provisions," as follows: "The amendments and supplements to these Rules and Regulations, adopted by the decision of the Academic Council under Protocol No. 30/29.10.2025, shall enter into force as of 1 October 2025."

Regarding the organisation of the educational process for newly admitted foreign students experiencing delays in obtaining a Type 'D' student visa and the necessary documents for enrolment

The Academic Council resolved:

- 1. Foreign applicants who have been accepted for admission and have confirmed their intention to enrol in the first year of study, but are unable to submit the required documents for student enrolment (including the Type 'D' visa for students from non-EU countries) within the specified deadline due to objective reasons, shall be permitted to begin their studies.
- 2. The enrolment deadline for the individuals under Item 1 shall be extended until 31 January 2026.
- 3. For those unable to enter the country due to delays in the issuance of the Type 'D' visa and, therefore, unable to attend in in-person training, training under an individual study plan (approved according to a schedule by the Dean) shall be provided, including online learning, until their arrival and official enrolment at the Medical University Varna.

Regarding the undertaking of a financial commitment in the amount of BGN 240,000.00 including VAT under Contract No. ZOP-DU-11/23.08.2024 with Consortium "Bulgaria Air and Posoka" SD for the provision of airline tickets and related services

The Academic Council resolved to undertake a financial commitment in the amount of BGN 240,000.00 including VAT, with the purpose of ensuring the implementation of services related to the provision of airline tickets for air transport of passengers and luggage for official travel within the country and abroad, as well as related activities assigned under Contract No. ZOP-DU-11/23.08.2024 with the contractor Consortium "Bulgaria Air and Posoka" SD. The execution of the contract shall continue within the financial resources determined by this decision.

Regarding the review of the results of inspections of the condition of the student dormitories and canteens managed by the Medical University "Prof. Dr. Paraskev Stoyanov" – Varna

The Academic Council approves the report on the inspections carried out regarding the condition of Student Dormitory Block 3 on Bregalnitsa Street, Student Dormitory Block 35 on Petar Raychev Street, and the student canteens of the Medical University "Prof. Dr. Paraskev Stoyanov" – Varna, as set out in the annexes to this decision.

Regarding out-of-warranty maintenance of a combined laser system for surgical treatment for the needs of the Medical University – Varna

The Academic Council resolved to perform out-of-warranty maintenance of a combined laser system, comprising a femtosecond laser model Visumax 800 and an excimer laser model MEL 90, with an estimated public procurement value of BGN 240,000.00 (two hundred and forty thousand) including VAT.
