Annotation

The discipline **Dental Public Health** aims to introduce students to the fundamental principles of Public Health and their application to resolving dental health related problems.

The syllabus includes topics from the subjects on the approaches to assessment, prevention and control of dental diseases in a population, promotion of dental health, as well as organization and management of dental healthcare.

It covers in details, together with fundamental Public Health topics, specific dental health problems such as:

- historical development of dental treatment and dental education;
- epidemiological approaches and specific indicators for assessment of dental diseases incidence;
- epidemiological designs for identification of the dental health risk factors:
- assessment designs for the efficiency of the new prevention and treatment methods and materials;
- prevention and promotion of dental health;
- organization, management and funding of healthcare;
- health policy and health legislation;
- management and marketing of dental practice;
- organization of the diagnostic and treatment process;
- dental ergonomics;
- professional risks and pathology in dental practice;
- assessment of healthcare demand, dental services demand;
- international aspects of dental health.

Forms of teaching, monitoring and evaluation:

The course includes lectures and seminars, including practical exercises.

Monitoring and evaluation is done through current control and semester examination - written exams (test) and individual project of the future dental practice.
