According to the e-reference, dr Angelov MD, PhD meets the requirements for occupation the academic degree "docent".

The scholar horarium presented from the University shows that dr Angelov has 695 hours in the recent five years.

Dr Angelov MD, PhD presents the following contributions:

For the first time in Bulgaria, he performed and validated the use of tumescent anesthesia as a method of choice in the treatment of varicose veins.

He clearly demonstrated that is not necessary the application of general or regional anesthesia for laser endovascular treatment.

The author proved that laser ablation can be performed even using of anticoagulants, antiaggregants or pacemaker without any risk for the patient.

He performed first in Bulgaria cosmetic transdermal without contact of broom type and net type veins less than 1mm. with laser energy without anesthesia.

The author proved that in patients with BMI > 50 – the laser treatment of varices has significant advantages comparing the open surgical treatment.

CONCLUSION:

The scientific activity of Dr. Angel Borisov Angelov MD PhD meets the requirements taking the academic degree "docent" which are defined of the rules of the Academic Staff at the Medical University "Prof. P.
