Dr. Miteva was born on March 25, 1988 in the town of Sliven. In 2013 she graduated from the Medical University "Prof. Dr. Paraskev Stoyanov ", Varna - Master - Dentist. In 2017 she acquired ONS "Doctor" in the specialty: "Therapeutic Dentistry" after defending a dissertation on "Effectiveness of high-energy lasers in non-surgical treatment of inflammatory diseases of the periodontium." In 2018 - acquired the specialty "Periodontology and diseases of the oral mucosa." In 2013 she became an assistant, and in 2018 - chief assistant in the Department of Periodontology and Dental Implantology at MU-Varna.

Scientific production

Dr. Miteva has 20 full-text publications, and for participation in the competition she presents 10 articles, 7 of which he is the first or only author. She also presents a monograph on "Non-surgical periodontal therapy" with a total volume of 168 pages. The main part of the publications, as well as her monograph in the field of periodontology. Three participations in scientific forums and two research projects were also presented.

The scientific works of Dr. Miteva have a number of confirmatory contributions mainly in the field of periodontology and can be arranged in the following areas:

1. Non-surgical treatment of inflammatory periodontal diseases
2. Additional means in non-surgical periodontal treatment
3. Choice of means in surgical periodontal therapy
4. Imaging of the periodontium

Teaching activity

Dr. Miteva has seven years of teaching experience as an assistant and chief assistant with a study load exceeding the required minimum according to the PRAS of MU-Varna for borrowing AD "Associate Professor".
